Notification of acceptance or rejection should occur on December 30, 2022, and accepted papers will be due in the final Proceedings form no later than January 13, 2023.

Email your paper or abstract to the conference chair at MariaMKwon@gmail.com. The submission process will close Friday, December 16, 2022.

1. Information to be entered during the paper entry process includes (1) the title of the paper, (2) the author(s) name(s), affiliation(s), and complete contact information, including mailing address(es) and email address(es).
2. The submission must be in Word format. The submission should include the title and, optionally, a one-paragraph abstract between the title and the body of the paper. The names of the author(s) should NOT be included.
3. At least one author of an accepted paper is required to register for the conference, and the paper must be presented at the conference by at least one author of the paper.
4. All participants of the WCNF 2023 conference must abide by the WCNF Code of Conduct at all times.
